



# US DATA PRIVACY LAW REFERENCE GUIDE



#### THE STATE OF DATA PRIVACY

The state of data privacy in the US — and around the world — seems to always be in transition. This guide provides links to the laws that have or will go into effect in 2023, as well as to those that are set to go into effect over the next two years. *Note: information is subject to change.*

## US DATA PRIVACY LAWS TAKING EFFECT IN 2023

#### **California Privacy Rights Act (CPRA)**

Effective January 1, 2023

### Virginia Consumer Data Protection Act (VCDPA)

Effective January 1, 2023

#### **Colorado Privacy Act (CPA)**

Effective January 1, 2023

#### **Connecticut Data Privacy Act (CTDPA)**

Effective January 1, 2023

#### **Utah Consumer Privacy Act (UCPA)**

Effective December 31, 2023



### US CONSUMER DATA PRIVACY LAWS PASSED IN 2023

Additional states have passed their own consumer data privacy laws. (As of summer 2023, the law in Delaware is pending governor approval.) These laws take effect in the next two years.

#### **Delaware Personal Data Privacy Act (DPDPA)**

Effective January 1, 2025, pending governor approval

#### **Indiana Data Privacy Law (IDPL)**

Effective January 1, 2026

#### Iowa Data Privacy Act (IDPA)

Effective January 1, 2025

# Montana Consumer Data Privacy Act (MTCDPA)

Effective October 1, 2024

#### **Oregon Consumer Privacy Act (OCPA)**

Effective July 1, 2024 (with a July 1, 2025, effective date for nonprofit organizations)

#### **Tennessee Information Protection Act (TIPA)**

Effective July 1, 2025

#### Texas Data Privacy and Security Act (TDPSA)

Effective July 1, 2024

# US CONSUMER DATA PRIVACY THAT MAY BE PASSED IN 2023

The following laws are still pending but could be enacted within the next year.

# American Data Privacy and Protection Act (ADPPA)

The American Privacy and Protection Act (ADPPA) could be the country's first comprehensive federal data protection law. It will have an impact on all businesses operating in the United States, whether domestic or foreign.
